OUR BUSINESS DEVELOPMENT

TERINOV's Business Development program was developed to reinforce support to companies already consolidated in international markets or initiating their internationalization projects. The creation of the Business Development program closes the incubation cycle, making it possible to support business initiatives during the different stages of hardship.

In contrast to conventional acceleration programs, TERINOV's Business Development program was created to support companies in a less invasive manner. Our goal is to not meddle with companies' business plans or models, nor to interfere with their projected value proposition. TERINOV's role within the scope of this program is to provide immaterial services that support the development of new products and services. Those services include access to a professional network, R&D activities, and privileged access to funding opportunities.

Eligibility

Startups, spin-offs, consolidated companies, or R&D entities that develop their activity, directly or indirectly, in the areas of Agribusiness, Cultural and

Creative Industries, Green Economy, or Information and Communication Technologies are considered eligible to TERINOV's Business Development program.

To be eligible, applicants must have a legal nature and an entrepreneurial mission to be developed. Startups and spin-offs must have up to 36 months of activity to be considered for the incubation program, except for initiatives that demonstrate and justify the motive for application.

All applications are analyzed and reviewed individually, taking into consideration topics such as the project's affiliation with the academic environment, it's framing in TERINOV's strategic areas, the perceived potential of the project, and the perceived ability of the team to pursue the objectives that the project proposes to develop.

Installation Spaces

Within the scope of TERINOV's incubation program, startups can implement their projects in spaces ranging from 35 to 50m2, in individualized offices, across a universe of 7 slots.

Complementary Spaces

In addition to the incubation spaces, startups, entrepreneurs and the staff of these entities can find support infrastructures designed at TERINOV to support them in the development of new products, services, technology and even test new approaches to the business model developed, namely:

Price

The amount charged to projects admitted under the incubation program is \in 6.00 per square meter, during the first year of installation, and \in 7.00 per square meter as of the second year.
